### 1305 To review any progress regarding the Neighbourhood Plan.

- 1305.1 The documentation is now in draft form and ready to be distributed when approved.
- 1305.2 There will be a 7/8 weeks consultation period.
- 1305.3 Councillors will meet to approve the documentation and deal with logistical aspects.

#### 1306 To discuss the Local Government Reorganisation engagement.

- 1306.1 National Government is proposing significant changes to how local councils operate.

  Currently, Gloucestershire comprises one county council and six smaller district councils, each responsible for different services.
- 1306.2 The proposal aims to replace them with fewer, larger councils that manage all services, known as 'unitary' authorities. Currently three options are under consideration:
  - One council covering the entire county.
  - Two councils, divided east (Cheltenham, Tewkesbury, and Cotswold) and west (Gloucester, Forest of Dean, and Stroud).
  - Two councils, one being an enlarged Gloucester city (referred to as 'Greater Gloucester'), and one for the remainder of the county.
- 1306.3 Input is required on how local services can best meet the needs of residents now and in the future. Feedback will help shape the proposals submitted to the Government this autumn.
- 1306;4 County-wide local government reorganisation survey | Have Your Say Gloucestershire
- 1306.5 Also refer to the Parish Council Web Site Local Government Reorganisation (LGR) engagement Uckington Parish Council

#### 1307 To update progress as to overgrown hedges and footpaths particularly at the bus stop.

- 1307.1 Action: The Clerk wrote to the new County Councillor Richard Stanley requesting assistance to help resolve this long outstanding issue but no progress has been made.
- 1307.2 The Chairman expressed his concern at the total lack of response, and he felt that we had no option but to proceed on a legal basis and take legal action as the GCC has a legal obligation attend to the issues raised. Cllr Jones agreed with this course of action as GCC had a duty of care and it had become a safety issue.
- 1307.3 In view of the Chairman's legal background, the clerk asked for a draft letter from the chairman to send on to the appropriate authorities.
